Agenda Item 1 was to call the meeting to order at 9:02 am by Mr. Kouri, Council Chairman.

Agenda Item 2 was to approve the August 17, 2018 Council Meeting Minutes.

Agenda Item 3 was to report on current Council activities and opening remarks by Chairman Kouri.

Agenda Item 4 was a report from the Department of Family and Protective Services' Commissioner. Commissioner Whitman provided updates on the following programs: Prevention and Early Intervention, the Human Trafficking Division, Child Protective Investigations, Child Protective Services, and Adult Protective Services.

Agenda Item 5 was a presentation on the Department's advisory committees. Cheryl Gomez, Council Liaison, gave updates on the Committee on Advancing Residential Practices, Advisory Committee on Promoting Adoption of Minority Children, Public Private Partnership, Prevention Task Force, Youth Leadership Council, and Parent Collaboration Group.

Kristene Blackstone, Associate Commissioner for Child Protective Services gave an overview of community based care and an update on the current regions where community based care has been implemented. Agenda Item 7 was a presentation on Adult Protective Services' (APS) audit and initiatives. Kezeli Wold, Associate Commissioner for Adult Protective Services, covered the State Auditor's Office audit for APS and the improvements the department has already made to improve APS.

Agenda Item 8 was a presentation on the status of Statewide Intake (SWI) and their fiscal year 2018 review. Ric Zimmerman, Associate Commissioner for Statewide Intake presented on the duties of SWI, call volume and changes made to streamline the intake calls.
