The meeting to order at 9:00 am by Judge Bonnie Hellums, Council Chair. Council members introduced themselves.

Cheryl Gomez, Council Liaison called the roll. Seven members were present, two were absent.

Judge Hellums determined that there was a quorum with seven council members present.

Judge Hellums recognized staff and special guests.

The council accepted the November 8, 2019 meeting minutes.

Judge Hellums reaffirmed the date of the next meeting, May 8, 2020.

Judge Hellums introduced Commissioner Masters. Commissioner Masters gave a report and thanked the council for their support.
