The meeting called to order at 9:00 am by Judge Bonnie Hellums, Council Chair.

Moment of silence for the tragedies on September 11, 2001.

Two new council members introduced themselves, Enrique Mata and Courtney Jones.

Roll was called, entire council was present.

Judge Hellums determined that there was a quorum with all council members present.

Judge Hellums recognized staff and special guests.

Commissioner Jaime Masters introduced herself.

Cheryl Gomez introduced the executive team.

The council accepted the February 14, 2020 meeting minutes.

Judge Hellums reaffirmed the date of the next meeting, November 13th, 2020.

Commissioner Masters gave a report on DFPS involvements regarding the lawsuit, PEI, and anti-trafficking initiatives.

Child Protective Services/CPI – Deneen Dryden and Jim Sylvester gave a report on their staff's passion for protecting families throughout the COVID-19 pandemic.

Adult Protective Services- Camille Payne gave a report on how APS responded quickly to the COVID-19 virus.

Community Based Care: Deneen Dryden gave a report on the region 3b, 2, 8b and their progress. She spoke on the implementation plan for December 2020, the process evaluation that comes with it, and the systems change efforts. Showed statistics on key stage 1 performance outcomes.
