If you've created previous reports, the list shows the date each report was submitted, the primary alleged victim, the report decision, a confirmation number, and a report ID. As a registered user, you have the option to save a draft to complete within the next 48 hours, so you might see information in the date draft created column. If you have a draft that is not yet submitted, the **Action** column allows you continue or delete the report draft. If you created a draft but never submitted it, the online reporting system automatically submits the draft after 48 hours and indicates submission in the automatically submitted column.
